On November 3, 2008, KCP&L Greater Missouri Operations Company (Company) filed with the Commission two (2) tariff sheets with an issue date of November 3, 2008, and a proposed effective date of December 3, 2008 to change the name of Aquila, Inc. dba KCP&L Greater Missouri Operations Company to KCP&L Greater Missouri Operations Company pursuant to 4 CSR 240-2.060(5).

On August 7, 2008, the Missouri Public Service Commission issued Order Recognizing Name Change And Approving Tariffs in Case No. EN-2009-0015 changing the Company's name from Aquila, Inc. d/b/a Aquila Networks – L&P and Aquila, Inc. d/b/a Aquila Networks – MPS to Aquila, Inc. dba KCP&L Greater Missouri Operations Company. At that time, Aquila, Inc. indicated that this name change would be interim until Aquila, Inc. was able to legally change its name to KCP&L Greater Missouri Operations Company.

Commission Rule 4 CSR 240-2.060(5) provides:

A name change may be accomplished by filing the items below with a cover letter requesting a change of name. Notwithstanding any other provision of these rules, the items required herein may be filed by a nonattorney. Applications for approval of a change of name shall include:

- (A) A statement, clearly setting out both the old name and the new name;
- (B) Evidence of registration of the name change with the Missouri secretary of state; and

(C) Either an adoption notice and revised tariff title sheet with an effective date which is not fewer than thirty (30) days after the filing date of the application, or revised tariff sheets with an effective date which is not fewer than thirty (30) days after the filing date of the application.

The Company's proposed filing has complied with the above requirements of Commission Rule 4 CSR 240-2.060(5) by (A) providing a cover letter that clearly states both the old and the new name, (B) attaching to the filing copies of registration of the name change with the State of Delaware, because Aquila, Inc. is a Delaware corporation, and with the State of Missouri and (C) the proper filing of an adoption notice clearly setting out both the old name and the new name and adopting the electric tariff of Aquila, Inc. currently on file with and approved by the Commission and the proper filing of a title sheet.

The Missouri Public Service Commission Energy - Tariff / Rate Design Staff (Staff) has reviewed the filed tariff sheets, and is of the opinion that they were timely filed and are in compliance with Commission Rule 4 CSR 240-2.060(5). Staff therefore recommends that the Commission **approve** the following proposed tariff sheets, as filed on November 3, 2008, to become effective on December 3, 2008 or permit the tariff sheets to go into effect by operation-of-law:
