REPORT ON FIFTH MILESTONE

COMES NOW Union Electric Company d/b/a AmerenUE (AmerenUE or Company), and for its Report on the Fifth Milestone, states as follows:

1. On January 24, 2007, the Missouri Public Service Commission (Commission) issued its *Order Granting Motion to Schedule a Technical Conference*. The conference was scheduled for February 1, 2007.
2. On February 1, 2007, the technical conference was held. At the technical conference, it was agreed by all parties that AmerenUE would commit to certain milestones.
3. The Commission accepted the proposed reporting schedule in its February 27, 2007 *Order Adopting Parties' Unanimous Resolution to Complaint*.
4. AmerenUE has previously filed reports on milestones one through four. The fifth and final milestone set forth in the proposed reporting schedule requires AmerenUE to report on outages at Mr. Smith's residence for the previous 12 months. That report is due on December 1, 2008.
5. An examination of AmerenUE's records reveal only one outage at Mr. Smith's residence for the previous 12 months. That outage occurred on March 27, 2008 and lasted for 42 minutes. It appears that a fuse failed during a storm. This, of course, is

how a fuse is supposed to operate and the failure of this fuse prevented a much more widespread outage in Mr. Smith's area.

WHEREFORE, AmerenUE respectfully requests the Commission accept this milestone report in response to the Commission's order of February 27, 2007.
