**FIRST AMENDED APPLICATION**

**COMES NOW** Southern Missouri Gas Company, L.P. d/b/a Southern Missouri Natural Gas, ("SMNG" or "Applicant"), pursuant to 4 CSR 240-2.080(20), and respectfully requests that it be granted leave to amend by interlineation its Application, including Appendix D, filed on October 13, 2009, as described herein:

1. On October 13, 2009, SMNG filed its Application in this matter requesting, among other things, that the Commission grant it a certificate of convenience and necessity on an expedited basis to construct, install, own, operate, control, manage, and maintain a system for the provision of natural gas service to the public pursuant to its approved rates, rules, and regulations contained in its tariff for Lebanon, Missouri, in the proposed service area in Laclede County, Missouri.

2. After discussing the Application with the Commission Staff, SMNG hereby requests authority to amend and supplement its Application as discussed below.

3. On page 1 of the Application, SMNG requests leave to insert or supplement by interlineation the following paragraphs after the conclusion of paragraph 3 in the original Application:

“A copy of SMNG’s limited partnership agreement was filed in Case No. GM-96-175, and a copy of its fictitious name registration was filed in Case No. GN-2006-0203 and are incorporated herein by reference.”

4. On page 3, SMNG requests leave to add the following sentences at the conclusion of paragraph 8:

“The Commission has approved a financing application for SMNG in Case No. GF-2007-0215 related to its expansion in the Lebanon and Branson area. The expansion of the service area requested in this case will be accomplished using a portion of the funds approved in Case No. GF-2007-0215. No additional financing is required to complete this project at this time.”

5. In addition, SMNG requests leave to correct two landowner addresses that were contained in Appendix D:

**WHEREFORE**, for the foregoing reasons, SMNG respectfully requests that it be granted leave to amend by interlineation its Application, including Appendix D, filed on October 13, 2009, as described herein, and hereby respectfully renews its request for an order from the Commission granting it a certificate of convenience and necessity on an expedited basis to construct, install, own, operate, control, manage, and maintain a system for the provision of natural gas service to the public pursuant to its approved rates, rules, and regulations contained in

its tariff for Lebanon, Missouri, in the proposed service area in Laclede County, Missouri, as more fully described herein.
