**FIRST AMENDED APPLICATION
FOR CHANGE OF ELECTRIC SERVICE PROVIDER**

COMES NOW City of Farmington, Missouri, by and through counsel, R. Scott Reid of Schnapp, Fall, Silvey, Reid & Bollinger, LLC, and for its First Amended Application for Change of Electric Service Provider, states to the Commission as follows:

1. Applicant City of Farmington's address is 110 West Columbia, Farmington, Missouri 63640.
2. The Applicant's current electrical service provider for the service locations described herein is Union Electric Company, d/b/a Ameren Missouri ("Ameren").
3. Applicant requests the Missouri Public Service Commission ("Commission") to order a change of electric supplier for the street lights located on Holly Tree Lane, Farmington, Missouri, which Ameren bills Applicant under accounts number 1951317127 and 3951317125.
4. Applicant requests the Commission to order a change of electric supplier from Ameren (current provider) to City of Farmington (requested provider).

5. This request for change of electric service provider is made for the reasons that the street lights located on Holly Street Lane are in an area that was developed outside the city limits of Farmington, Missouri. Ameren began providing electric service to the area before it was annexed by the City of Farmington. Due to the annexation and subsequent construction and development, the City of Farmington and now provides water, sewer and electric services in the area adjacent to Holly Tree Lane and the street lights at issue in this matter.


6. In 2016 the City of Farmington constructed a new substation and distribution main in a nearby location. The City wishes to provide electrical service for the street lights located on Holly Tree Lane, which are adjacent to structures and homes currently served by the City of Farmington.

7. The City has conferred with Ameren regarding this Application for Change of Service and Ameren has indicated that it is in agreement with the City of Farmington's request to provide service to the street lights at issue in this Application.

8. This Application to change service provider is limited to the street lights located on Holly Tree Lane and no other service areas or structures are involved in this Application.

WHEREFORE, Applicant requests the Missouri Public Service Commission to issue its Order changing the current electric service provider for the street lights located on Holly Tree Lane in Farmington, Missouri (Ameren accounts 1951317127 and 3951317125) to the City of Farmington.


