The Commission will issue notice to the persons and entities recommended by Staff. The Commission will also set a deadline for filing any interventions and for a Staff recommendation.

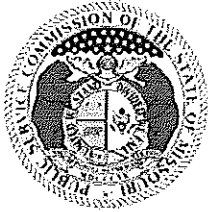
#### THE COMMISSION ORDERS THAT:

3. Any entity wishing to intervene in this matter shall do so, no later than October 4, 2019.

4. The Staff of the Missouri Public Service Commission shall file a recommendation in this case no later than October 11, 2019.

5. This order shall be effective when issued.




