Surrebuttal Testimony of
Brad J. Fortson

1 A. On page 3 of Mr. Hackney’s rebuttal testimony he states, “[...]Empire is
2 willing to work with Staff, DE, and the other parties in this case to discuss and consider
3 proposed changes to correct any alleged inaccuracies in its DSM tariff language.”¹

4 Q. Did you make specific recommendations concerning Empire’s current DSM
5 programs in your rebuttal testimony?

6 A. Yes. I recommended Empire work with the parties in this case to reach
7 agreement on program designs and annual spending levels for: (a) the low-income
8 weatherization program,² and (b) a new Empire low-income energy efficiency program.
9 Therefore, the new low-income program tariff sheets would be the only Empire DSM tariff
10 sheets of concern. Of course, if all of Empire’s current energy efficiency programs are
11 discontinued consistent with the Empire adopted preferred resource plan, then all tariff sheets
12 for current programs would be cancelled.

13 Q. Does that conclude your surrebuttal testimony?

14 A. Yes.

² The low-income weatherization program is not currently a part of Empire’s DSM portfolio and costs of the program are recovered in permanent rates. However, the annual spending level for this program is an issue in this rate case.

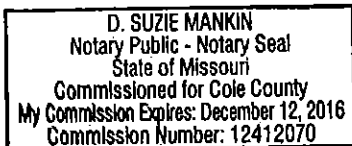


