REPORT ON FOURTH MILESTONE

COMES NOW Union Electric Company d/b/a AmerenUE (AmerenUE or Company), and for its Report on the Fourth Milestone, states as follows:

1. On January 24, 2007, the Missouri Public Service Commission (Commission) issued its *Order Granting Motion to Schedule a Technical Conference*. The conference was scheduled for February 1, 2007.
2. On February 1, 2007, the technical conference was held. At the technical conference, it was agreed by all parties that AmerenUE would commit to certain milestones, including completion of the substation and reconductoring of certain lines. AmerenUE previously reported on the completion of the first milestone. The second milestone listed required the rebuilding of the existing single phase line from Younkers Road to John Smith Road and the third milestone was for the installation of fuses at Mr. Smith's property or near the end of the line serving Mr. Smith, if determined beneficial. Both of these tasks were to be completed no later than September 1, 2007.
3. The Commission accepted the proposed reporting schedule in its February 27, 2007 *Order Adopting Parties' Unanimous Resolution to Complaint*.
4. As of November 1, 2007, all work on the northern feeder out of AmerenUE's new Belgrade substation is completed. Mr. Smith is now served off of

approximately five miles of new three phase 25kv distribution circuit from a new tap connecting to a 161kv transmission circuit through a new 161kv/25kv transformer. All reconductoring work on Mr. Smith's circuit is complete.

WHEREFORE, AmerenUE respectfully requests the Commission accept this milestone report in response to the Commission's order of February 27, 2007.
