On October 1, 2021,¹ Spire Missouri, Inc. d/b/a Spire (Spire) filed a status report advising the Commission that the parties were filing a Stipulation and Agreement (Stipulation) in File No. GA-2021-0259 that entailed Spire’s dismissing its application in this file, GA-2021-0216. On December 1, Spire filed a status report stating that the Commission approved the stipulation in File GA-2021-0259 by order effective on December 11. Spire stated that until the GA-2021-0259 order was effective, it did not deem that case resolved and requested the Commission order it to file a status report or other appropriate pleading in this file no later than January 1, 2022. Spire states that Staff does not object. The Commission will grant the request.

THE COMMISSION ORDERS THAT:

1. No later than January 3, 2022, the parties shall file a status report or other pleading.
