ORDER DIRECTING NOTICE AND DIRECTING FILING

On August 12, 2022, the Commission received the above-referenced application to continue as a 211 provider for an additional three years. The Commission ordered its Staff to file a list of entities that it believes the Commission should notify of the application. Staff did so on August 25, 2022.

The Commission will issue notice to the persons and entities recommended by Staff. The Commission will also set a deadline for filing any interventions and for a Staff recommendation.

THE COMMISSION ORDERS THAT:

1. The Data Center of the Commission shall provide notice to the entities listed in Attachment A of Staff's August 25, 2022 pleading.
2. The Public Policy and Outreach Department of the Commission shall provide notice of the application to the members of the General Assembly representing residents of the counties and to news media serving residents of the counties listed in Schedule 1 of the application attached to this order.

3. Any entity wishing to intervene in this matter shall do so, no later than October 4, 2022.

4. The Staff of the Missouri Public Service Commission shall file a recommendation in this case no later than October 11, 2022.

5. This order is effective when issued.
