**JOINTLY PROPOSED REQUEST FOR EXTENSION OF CERTAIN FILING DATES**

COMES NOW the Staff of the Missouri Public Service Commission (“Staff”), by and through the Staff Counsel’s Office, on behalf of the “Parties” in File Nos. EA-2013-0098 and EO-2012-0367, i.e., the Staff, the Office of the Public Counsel (“OPC”), Missouri Industrial Energy Consumers (“MIEC”),<sup>1</sup> and the Applicants Transource Missouri, LLC (“Transource Missouri”),<sup>2</sup> Kansas City Power & Light Company (“KCP&L”), and KCP&L Greater Missouri Operations Company (“GMO”),<sup>3</sup> and files this *Jointly Proposed Request For Extension Of Certain Filing Dates*.

1. On December 17, 2012, the Commission issued an Order Modifying Procedural Schedule in which it moved the evidentiary hearing dates from March 27-29, 2013 to April 2-4, 2013 pursuant to a request from the Office of the Public Counsel. The Commission did not move the date for the filing of the (i) List of Issues, Order of Witnesses, Order of Cross-

Examination, Order of Opening Statements – March 19, 2013; (ii) Joint Stipulation of Non-Disputed Material Facts – March 20, 2013; and (iii) Position Statements – March 21, 2013.

2. Due to settlement discussions that are to occur the Parties request that the aforementioned dates for filings this week be extended one week to the corresponding days next week which will be the week preceding the scheduled evidentiary hearing. The new dates for filings would be as follows: (i) List of Issues, Order of Witnesses, Order of Cross-Examination, Order of Opening Statements – March 26, 2013; (ii) Joint Stipulation of Non-Disputed Material Facts – March 27, 2013; and (iii) Position Statements – March 28, 2013. The evidentiary hearing would still be scheduled for April 2-4, 2013.

3. The Parties do not make this request so as to unduly delay these proceedings.

**WHEREFORE** the Staff on behalf of the Parties in File Nos. EA-2013-0098 and EO-2012-0367 files the instant *Jointly Proposed Request For Extension Of Certain Filing Dates*.
