

ORDER DIRECTING FILING REGARDING TAX INFORMATION

Issue Date: September 25, 2015 Effective Date: September 25, 2015

Section 393.275.1, RSMo 2000, requires the Commission to notify the governing body of each city or county imposing a business license tax on gross receipts of any electric corporation of any approved rate increase for that electric corporation that exceeds seven percent. As directed by the Commission, on September 8, 2015 Kansas City Power & Light Company ("KCPL") filed information on gross receipts taxes paid to cities in 2013, but designated that information as highly confidential. The Commission will direct KCPL to provide an explanation as to why that information has been classified as highly confidential.

THE COMMISSION ORDERS THAT:

1. No later than September 30, 2015, Kansas City Power & Light Company shall file an explanation as why the gross receipts tax information filed on September 8, 2015 has been classified as highly confidential.

2. This order shall be effective when issued.
