The Missouri Public Service Commission is granting KCP&L Greater Missouri Operations Company's ("GMO") motion to extend effective date¹ ("motion"). The motion asks the Commission to extend the effective date of the *Order Approving Compliance Tariffs*² from December 22, 2016, to February 22, 2017. In support, GMO states that, despite diligent efforts to implement new rates, it remains unable to generate bills accurately reflecting the new rates. The motion represents that Staff, The Office of Public Counsel, Midwest Energy Consumers Group, Brightergy, LLC, and City of St. Joseph, Missouri—all the parties that have responded to GMO's contacts—do not oppose the motion. The Commission will grant the motion.

THE COMMISSION ORDERS THAT:

1. *KCP&L Greater Missouri Operations Company's Request to Delay Effective Date of Order and Motion for Expedited Treatment* is granted.
2. The effective date of the *Order Approving Compliance Tariffs* is extended to February 22, 2017.
