## ORDER INCORPORATING LIST OF ISSUES AND ORDER REGARDING POSITION STATEMENTS

The Commission is incorporating into this order the proposed list of issues and other provisions related to the evidentiary hearing filed by Staff.<sup>1</sup>

Staff's filing suggests that fewer than all parties have responded to Staff's solicitations of issues for hearing. It also suggests that Staff may have to update or correct the list of issues. The procedural schedule provides that Staff co-ordinates the list of issues, and that the list of issues governs position statements.<sup>2</sup> Position statements constitute notice to the Commission, and the parties, of which issues to prepare for the evidentiary hearing. Therefore, the Commission will amend or supplement the issues list only after considering the recommendation of Staff and the other parties.

Any position not listed in a position statement filed in co-ordination with Staff's issues list shall be deemed abandoned.


