OF AG PROCESSING INC.**


Comes now AG PROCESSING INC, a COOPERATIVE ("AGP"), and pursuant to the Commission's April 3, 2003 Second Order Establishing Time for Response states:

1. AGP personnel have reviewed the tariff filing by Missouri-American on April 1, 2003.
2. While the filing does not address working capital or cost saving issues, AGP recognizes that these issues may more properly be addressed in the context of a rate case.
3. The April 1, 2003 filing addresses AGP's concerns regarding due date and date of delinquency as stated in AGP's filing of March 17, 2003. AGP no longer has objection to them nor does it requests a hearing regarding them on the basis stated.
4. AGP takes no position regarding any changes proposed to the fire service tariff in any district.

WHEREFORE, AGP prays that its response as above be duly considered by the Commission.


