STAFF'S EXTENSION OF TIME AND STATUS REPORT

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and for its request for an extension of time and its Status Report to the Missouri Public Service Commission's (Commission) Order, states as follows:

1. A total of four affidavits have been provided and three affidavits have

subsequently been filed within the above referenced case numbers. Documentation has also been received with two of the affidavits.

2. Staff is expecting two additional affidavits to be submitted during the week of

June 1, 2010. These affidavits are instrumental in determining whether or not Staff should execute any of the subpoenas served on Peter N. Brown, Cynthia Goldsby, RPS Properties, L.P., Sally Stump, Vernon Stump and/or John Summers, or whether any of the these witnesses should be presented to the Commission through an evidentiary hearing.

3. Staff will request that any such affidavits be marked and entered into evidence, and possibly some of the documentation. Such requests to make an evidentiary record may be objected to by other parties to this proceeding. Therefore, Staff believes it would be the most reasonable path to set aside one day for hearing for the limited purpose of addressing proposed evidence, which will allow objections to be made and ruled on without the undue delay of rounds of responsive filings.

4. However, as Staff has not yet received two remaining affidavits, Staff is uncertain whether depositions or more than one day of evidentiary hearing is necessary to provide the information the Commission needs to effectively adjudicate these cases.

5. Upon receipt of the above expected two affidavits, or no later than June 4, 2010, Staff will immediately notify the Commission as to whether more than one day of evidentiary hearing is necessary beyond the limited purpose as described above.

6. Therefore, Staff requests an extension until Friday, June 4, 2010 to inform the Commission of whether more than one day of evidentiary hearing is necessary. For potential scheduling purposes, Staff notes that the parties may have significant conflict dates for the month of June.

7. Staff also requests that the Commission accept this Status Report ordered to be filed no later than Thursday June 3, 2010.

WHEREFORE, Staff respectfully moves this Commission to grant Staff an extension until June 4, 2010, and respectfully requests the Commission accept this Status Report.
