
Section 386.420.4, RSMo Supp. 2013, requires the Commission to cause to be prepared and to approve a detailed reconciliation regarding the dollar value and rate or charge impact of the contested issues decided by the Commission in this case. The Commission will direct Kansas City Power & Light Company to prepare and file a reconciliation and provide an opportunity for other parties to respond to the reconciliation.

THE COMMISSION ORDERS THAT:

1. Kansas City Power & Light Company shall file a reconciliation pursuant to Section 386.420.4, RSMo Supp. 2013, no later than October 8, 2015.
2. Any party wishing to respond to the reconciliation filed by Kansas City Power & Light Company shall do so no later than October 15, 2015.

3. This order shall be effective when issued.




