**ORDER DIRECTING NOTICE, SETTING INTERVENTION DEADLINE,
AND SETTING PROCEDURAL CONFERENCE**

On October 30, 2014, Kansas City Power & Light Company (“KCP&L”) submitted a tariff designed to implement a general rate increase for electric utility service. KCP&L indicates the new electric utility service rates are designed to increase its annual revenues by approximately 15.75%. The submitted tariffs carry an effective date of November 29, 2014.

The Commission’s Data Center shall serve a copy of this order upon the county commissions of the counties in KCP&L’s service area. In addition, the Commission’s Public Information Office shall make notice of this order available to the media serving KCP&L’s service area and to the members of the General Assembly representing that area. The Commission will allow entities, groups, or persons 20 days from the issuance of this order to file an application to intervene. The Commission will also set a prehearing conference.

THE COMMISSION ORDERS THAT:

1. The Commission’s Data Center shall serve a copy of this order upon the county commission of each county within Kansas City Power & Light Company’s service area.
2. The Commission’s Public Information Office shall make notice of this order available to the members of the General Assembly representing Kansas City Power & Light

Company's service area and to the news media in Kansas City Power & Light Company's service area.

3. Any entity, group, or person wishing to intervene shall file an application to intervene no later than November 20, 2014.

4. A prehearing conference shall be held on Monday November 24, 2014 at 10:00 a.m. The prehearing conference will be held in Room 310 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri. This meeting will be held in a building that meets accessibility standards required by the Americans with Disabilities Act. Anyone needing additional accommodations to participate shall call the Public Service Commission's Hotline at 1-800-392-4211 (voice) or Relay Missouri at 711 before the conference.

5. Any party that wants to participate in the conference by phone may do so by calling toll-free 866-630-9356 at the time set for the beginning of the conference.

6. Any requests for intervention not already granted may be ruled upon at the prehearing conference.

7. This order shall be effective when issued.
