ORDER APPROVING FUEL ADJUSTMENT CLAUSE TRUE-UP

Issue Date: September 10, 2014 Effective Date: September 23, 2014

On July 25, 2014, Union Electric Company d/b/a Ameren Missouri filed an application containing its 13th Fuel Adjustment Clause ("FAC") true-up filing. Ameren Missouri identified the amounts of over or under-recovery during the previous 8-month FAC recovery period.

The Commission's rules regarding fuel adjustment clauses requires the Commission's Staff to examine and analyze the information submitted by Ameren Missouri and to submit a recommendation within 30 days. Staff filed its recommendation on August 22, 2014. Based on its examination and analysis of information filed by Ameren Missouri, including the direct testimony of Ameren Missouri's witness Erik Wenberg, and supporting schedules, Staff recommends the Commission approve Ameren Missouri's true-up filing amounts of \$2,611,772 over-collection during Recovery Period 13 ("RP13") for the billing months of October 2013 through May 2014.

The true-up amount of RP13, with a calculated interest of \$110,252, is included in Ameren Missouri's Accumulation Period 16 FAC adjustment filing, currently before the Commission in File No. ER-2015-0022.

More than ten days have passed since Staff filed its recommendation, and no party has filed a response to that recommendation.³ Based on the Direct Testimony of Erik Wenberg, submitted by Ameren Missouri along with its application, as well as the uncontested recommendation of Staff, the Commission will approve Ameren Missouri's true-up filing.

THE COMMISSION ORDERS THAT:

- 1. Union Electric Company d/b/a Ameren Missouri's true-up filing for the thirteenth recovery period (October 2013 through May 2014) is approved.
 - 2. This order shall become effective on September 23, 2014.
 - 3. This file shall be closed on September 24, 2014.
