The Missouri Public Service Commission concluded an on-the-record presentation¹ regarding the *Non-Unanimous Stipulation and Agreement Regarding Pensions and Other Post-Employment Benefits*² and the *Non-Unanimous Stipulation and Agreement*³ (“the stipulations”). Those documents request an order embodying the substantive provisions of those documents. Contingent on a favorable ruling, they also stipulate to the entry of the parties’ hearing exhibits into the record. The Commission has convened no evidentiary hearing so the Commission has not received those exhibits marked⁴ as prescribed by Commission order.⁵ Therefore, the Commission will order the parties to file marked copies of those exhibits, pending the Commission’s ruling on the stipulations.

THE COMMISSION ORDERS THAT:

1. No later than September 27, 2016, each party shall mark such party’s hearing exhibits according to that party’s exhibit list and file such marked exhibits.
