**ORDER DIRECTING STAFF TO FILE EXPEDITED  
RECOMMENDATION AND ESTABLISHING TIME FOR OTHER  
PARTIES TO OFFER RECOMMENDATIONS**

On March 8, 2017, the Commission approved a unanimous stipulation and agreement that resolved all issues in the general rate case filed by Union Electric Company, d/b/a Ameren Missouri. The Commission's order rejected Ameren Missouri's previously-filed tariff to increase its annual revenues, but authorized it to file a tariff sufficient to recover revenues as determined in the approved stipulation and agreement. Ameren Missouri filed its compliance tariff on March 8.

Ameren Missouri's compliance tariff carries a 30-day effective date that would put the tariff in effect on April 7. However, Ameren Missouri filed a motion along with its tariff asking the Commission to expedite its consideration of the compliance tariff and to approve the tariff to go into effect on April 1.

The Commission will order its Staff to file an expedited recommendation regarding Ameren Missouri's compliance tariff, and will establish a date by which other interested parties may file a recommendation regarding that tariff.

**THE COMMISSION ORDERS THAT:**

1. The Commission's Staff shall file its recommendation regarding Ameren Missouri's compliance tariffs, Tariff No. YE-2017-0173, no later than March 16, 2017.
2. Any other party wishing to file a recommendation regarding Ameren Missouri's compliance tariffs, Tariff No. YE-2017-0173, shall do so no later than March 16, 2017.
3. This order shall be effective when issued.
