ORDER REQUIRING STAFF REPLY

On July 26, 2019,¹ the Staff of Missouri Public Service Commission ("Staff") filed its recommendation in ER-2019-0414 that the Commission approve the true-up amount proposed by KCP&L Greater Missouri Operations Company ("GMO"). On July 26, the Staff also filed its recommendation in ER-2019-0413 that the Commission allow the accompanying tariff, Tracking Number JE-2019-0232, to go into effect on September 1 by operation of law. On August 5, the Office of Public Counsel ("OPC") filed its Response to Staff's recommendation in ER-2019-0413 and requested the Commission reject GMO's proposed tariff, and order GMO to file a new substitute tariff conforming with accounting adjustments detailed in OPC's response. The Commission will order Staff to reply to OPC's response, and will establish a time for other parties to reply.

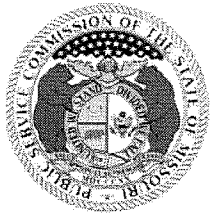

1. The Staff of the Missouri Public Service Commission shall file a reply to the Response to Staff Recommendation filed by the Office of Public Counsel in ER-2019-0413 no later than 9 a.m. on August 12, 2019.

2. Any other party wishing to reply to the Response to Staff Recommendation filed by Office of Public Counsel in ER-2019-0413 shall do so no later than 9:00 a.m. on August 12, 2019.

3. This order shall be effective when issued.




