# ORDER REJECTING FUEL ADJUSTMENT CLAUSE TARIFF, SCHEDULING A PROCEDURAL CONFERENCE AND DIRECTING THE FILING OF A REVISED TARIFF

Issue Date: August 15, 2019 Effective Date: August 31, 2019

On June 28, 2019, KCP&L Greater Missouri Operations Company ("GMO") submitted an application containing its 21<sup>st</sup> recovery period true-up filing for its fuel and purchased power adjustment clause ("FAC") in Commission File No. ER-2019-0414. GMO also sought approval of the fuel adjustment rates ("FARs") used to calculate its FAC charge to customers for accumulation period 24 ("AP 24") in Commission File No. ER-2019-0413. GMO requested the Commission authorize these adjustments by revised FAC tariff sheet, Tracking No. JE-2019-0232. The tariff sheet's effective date is September 1, 2019.

After reviewing GMO's filings, the Commission's Staff filed a recommendation the Commission approve the proposed true-up and allow GMO's Sheet No. 127.23, as substituted July 25, 2019, to take effect on September 1, 2019, by operation of law. On August 5, 2019, the Office of Public Counsel ("OPC") filed its Response to Staff

Recommendation. OPC opposed Staff's recommendation for the stated reasons that GMO's substitute tariff sheet includes a \$311,381.00 cost for auxiliary power GMO uses for steam operations at its Lake Road station and includes a \$518,248.00 cost for propane and coal removal at the retired Sibley generation facility. On August 12, 2019, Staff and GMO replied to OPC. They argued OPC's calculations were incorrect, the adjustments (properly calculated) were in accordance with Commission Rule 4 CSR 240-20.090, and, in any event, the issues in question were either now pending or should be determined in prudence review proceedings.

As the adjustments at issue are alleged not to be in accordance with the rule, Section 386.266, RSMo, and the FAC mechanism established in the electric utility's most recent general rate proceedings, the Commission will order the following, all in accordance with Commission Rule 4 CSR 240-20.090(8)H.3: reject the substitute tariff, JE-2019-0232; suspend the timeline of the FAR adjustment filing; set a prehearing date; order the parties to propose a procedural schedule; and order the Company to file a tariff sheet to implement interim adjusted FARs to reflect that part of the proposed adjustment that is not in question. In doing so, the Commission makes no finding whether the substitute tariff JE-2019-0232 is in accordance with the rules, statutes, and FAC mechanism established in the Company's most recent general rate case. The Commission will make such findings after hearing the evidence presented by the parties. The Commission will make no findings regarding the true-up amount for recovery period 21 at this time. As the rejected tariff with tracking number JE-2019-0232 has an effective date of September 1, 2019, the Commission will make this order effective on August 31, 2019.

#### THE COMMISSION ORDERS THAT:

- 1. The tariff assigned Tracking No. JE-2019-0232 is rejected.
- 2. The timeline of the FAR adjustment filing is suspended.
- 3. The case is set for prehearing on September 5, 2019, at 9:00 a.m.
- 4. The prehearing conference will convene in Room 305 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri 65102. The building meets accessibility standards required by the Americans with Disabilities Act. Any person who needs accommodations to participate in the conference or hearing shall contact the Commission, no later than the day before the conference. - 6. The parties shall file a proposed procedural schedule no later than September 12, 2019.
- 7. KCPL Greater Missouri Operations Company shall file tariff sheet(s) to implement interim adjusted fuel adjustment rates to reflect any part of the proposed adjustment that is not in question.
  - 8. This order shall be effective on August 31, 2019.
