ORDER FURTHER MODIFYING PROCEDURAL SCHEDULE

Issue Date: December 2, 2021

Effective Date: December 2, 2021

After a previous modification, these cases are set for hearing beginning on December 6, 2021, with the procedural schedule requiring the filing of statements of position on December 2, and a final reconciliation on December 3. On December 2, Union Electric Company d/b/a Ameren Missouri, acting on behalf of itself and the other parties, filed a motion asking the Commission to further modify the remaining procedural schedule. The motion explains that the parties have reached an agreement in principle regarding all remaining issues in the natural gas case and that nearly all remaining issues in the electric case have been resolved by a previous stipulation and agreement. The parties believe that the remaining issues in the electric case can be resolved at hearing on Thursday, December 9, continuing on Friday December 10, if necessary. For that reason, the moving parties ask that the filing date for statements of position be moved back to Tuesday, December 7. They also represent that because all revenue requirement issues in both the electric and natural gas cases have been resolved, there is no longer a need to file a reconciliation.

The Commission will further modify the remaining procedural schedule, but will require the parties to file their position statements no later than 9:00 a.m. on December 7, to allow the Commission sufficient time to prepare for a hearing of any remaining issues.

THE COMMISSION ORDERS THAT:

1. The procedural schedule is modified to require the parties to file statements of position by no later than 9:00 a.m. on December 7, 2021.
2. The requirement to file a final reconciliation is eliminated.
3. The evidentiary hearing will begin on December 9, 2021, at 8:30 a.m., and continue through December 10, 2021 (if necessary).
4. This order shall be effective when issued.
