ORDER DIRECTING STAFF RECOMMENDATION ABOUT LIBERTY'S COMPLIANCE TARIFF SHEET AND SETTING A DEADLINE FOR OTHER RESPONSES

Issue Date: July 5, 2022

Effective Date: July 5, 2022

On July 1, 2022, The Empire District Electric Company d/b/a Liberty filed tariff revision Tariff No. YE-2023-0001. Liberty states that it discovered a revised tariff sheet was inadvertently not filed for changes to Liberty's Low Income Pilot Program. This compliance tariff sheet was submitted to implement those changes. The tariff sheet bears an effective date of July 31, 2022. The Commission will direct its Staff to file a recommendation informing the Commission of whether this tariff sheet complies with the Commission's Report and Order and the approved stipulation. The Commission will also set a deadline for any other responses to Liberty's compliance filing.

THE COMMISSION ORDERS THAT:

1. The Staff of the Commission shall file a recommendation about Liberty's compliance tariff sheet no later than July 14, 2022.
2. Any other response to Liberty's compliance tariff sheet is due no later than July 14, 2022.

3. This order is effective when issued.
