MOTION TO INTERVENE OF GOOGLE LLC

COMES NOW Google LLC, pursuant to Commission Rule 20 CSR 4240-2.075, files this Motion to Intervene, and in support thereof respectfully states as follows:

1. On January 7, 2022, Evergy Missouri Metro, Inc. d/b/a Evergy Missouri Metro (“Evergy Metro”) filed revised tariff sheets designed to implement a general rate increase along with supporting testimony. On January 12, the Commission issued an order establishing an intervention deadline of February 11.

2. Google LLC is a limited liability corporation duly incorporated under the laws of the State of Delaware. The Company’s principal office is located at 1600 Amphitheatre Parkway, Mountain View, CA 94043. The contact information for Google LLC’s attorney is set forth below.

3. Google LLC has an interest in potentially developing Data Center Facilities in the Evergy Metro service territory. If those Data Center Facilities are developed, Google would be one of the largest and highest load factor customers on the Evergy Metro system, and so Google LLC has an interest in this proceeding different from that of the general public. In addition, Google LLC has experience in acquiring power and taking electric service in jurisdictions around the country. By allowing Google LLC’s intervention, the Commission can use that knowledge and experience to decide the case in a manner that best serves the public interest.

4. Google LLC has not yet developed positions on specific issues that may arise this case proceeds.

WHEREFORE, Google LLC respectfully requests that the Commission issue its order granting intervention and permitting Google LLC to intervene and participate as a party in all respects in this proceeding.
