On January 30, 2023, Union Electric Company d/b/a Ameren Missouri filed a motion on behalf of itself and the Staff of the Commission (Staff) requesting that the Commission cancel the February 9, 2023, technical conference. In support of the motion Ameren Missouri states that the conference is unnecessary because the conference is on the same day as the February 9, 2023, local public hearings being held in the St. Louis area and Ameren Missouri and Staff have been engaged in multiple meetings concerning the revenue requirement. The motion represents that counsel for the other parties have been informed of this request and do not object.

The Commission will modify the procedural schedule to cancel the technical conference.

1. The technical conference set for February 9, 2023, is canceled
2. The remainder of the procedural schedule is unmodified.
