In the matter of Union Electric Company
of St. Louis, Missouri for authority to
file revised tariffs for incandescent
lighting service provided to customers
in the Missouri service area of the
company.

ORDER AND NOTICE OF HEARING

On December 26, 1979, Union Electric Company of St. Louis, Missouri submitted to this Commission revised tariffs designed to limit maintenance on private area and municipal incandescent lighting for electric service provided to customers in the Missouri service area of the Company. The proposed tariffs had a requested effective date of January 28, 1980.

By order dated January 25, 1980, the Commission suspended said proposed tariffs for a period of 120 days, until May 27, 1980, and, by order dated May 27, 1980, further suspended said proposed tariffs for an additional period of six months, until November 27, 1980.

The Commission is of the opinion that a hearing should be scheduled in this matter and notice provided as hereinafter ordered.

It is, therefore,

ORDERED: 1. That a hearing in Case No. ER-80-190 be, and is, hereby scheduled for October 2, 1980, at 10:00 a.m. in the Commission's hearing room on the tenth floor of the Jefferson State Office Building in Jefferson City, Missouri at which time all parties shall present testimony, exhibits and witnesses for examination and cross-examination concerning the revised tariffs.

ORDERED: 2. That the Secretary of the Commission shall serve a copy of this order upon all of Union Electric Company's private area and municipal customers of incandescent lighting.

ORDERED: 3. That any person or entity desiring to intervene and become a party to this proceeding shall file its application to intervene with the Commission on or before August 22, 1980, in accordance with 4 CSR 240-2.1(2)(2), and shall serve a copy of the application upon:
