**MOTION TO POSTPONE HEARING IN ANTICIPATION OF VOLUNTARY
DISMISSAL AND TO SET ASIDE FILING OF LIST OF WITNESSES AND
ISSUES**

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and for its Motion, respectfully states as follows:

1. On August 8, 2007, the Commission issued its Order Setting Complaint for hearing on September 11, 2007, and Directing the Filing of a List of Issues and Witnesses by September 7, 2007.

2. On September 6, 2007, the Company informed Staff that it had reached a resolution with the Complainant to the matters at issue in the Complaint, and that Complainant would shortly file a Notice of Dismissal.

3. Because Staff anticipates the filing of a Notice of Dismissal by September 21, 2007, Staff requests that the Commission set aside the parties' requirement to file a Lists of Issues and Witnesses for this case. Staff also requests that the Commission cancel the hearing date of September 11, 2007.

4. Staff proposes that if no Notice of Dismissal has been filed by September 20, 2007, Staff and all other parties be directed to file their Lists of Issues and Witnesses not later than September 21, 2007, and that the hearing date be re-set.

WHEREFORE, Staff requests that the Commission set aside its order directing the parties to file their Lists of Issues and Witnesses and cancel the September 11th hearing in anticipation of the filing of a Notice of Dismissal.
