2 JUDGE CLARK: Good evening. It is January 15th of
3 2020 and it is around 6:19 p.m. We are in Cape Girardeau,
4 Missouri. The Missouri Public Service Commission has set
5 aside this time for a local public hearing in File Number
6 ER-2019-0335 which is captioned as: In the Matter of Union
7 Electric Company doing business as Ameren Missouri's Tariffs
8 To Decrease Its Revenues For Electric Service.

9 My name is John Clark. I'm the Regulatory Law
10 Judge presiding over this local public hearing.

1 JUDGE CLARK: Thank you, Mr. Hall.

3 I'm going to note for the record that the
4 Commission set a question and answer session to start at
5 6:00 p.m. followed by public comments session. At this
6 point as I said before, it's right around 6:20 p.m. and no
7 one has appeared for the Q and A or the public comment.

9 for the question and answer session and I hope they were
10 able to get their questions answered.

11 The Commission provides local public hearings so
12 that interested members of the public have an opportunity to
13 ask questions of the Company, Commission staff and the
14 Office of the Public Counsel and also have an opportunity to
15 comment directly to the Commission.

16 Interested members of the public may still provide
17 written comments through the PSC website or by contacting
18 the Office of the Public Counsel.

19 With that in mind, this hearing is now adjourned.
20 Have a good evening and we'll go off the record.
