Comes now The Empire District Electric Company ("Empire"), by and through its counsel, and for its motion respectfully states as follows:

- 1. On June 4, 2002, the Commission issued an "Order Granting Extension of Time to File Response." It moved the deadline for a response to the Staff's motion to consolidate this case with the pending rate case (Case No. ER-2002-424) from May 23, 2002 to July 22, 2002.
