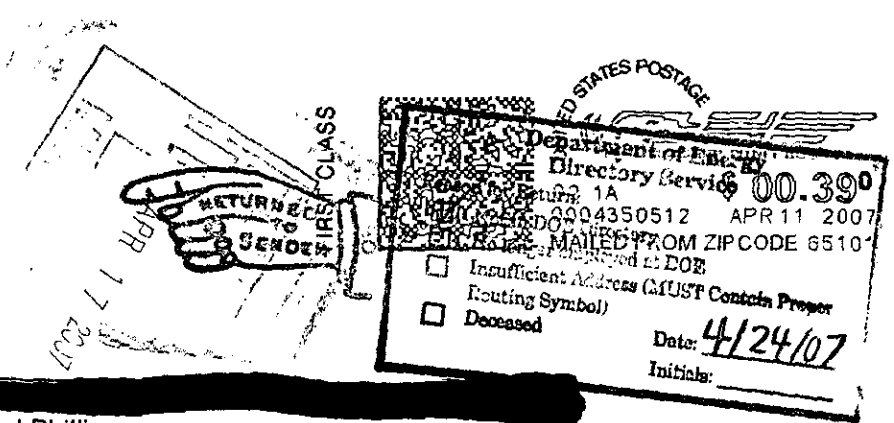

On April 5, 2007, Kansas City Power & Light filed tariff sheets designed to make changes to its MPower program. The program is the result of a Stipulation and Agreement reached in KCPL's Regulatory Plan, Case No. EO-2005-0329. The tariff sheets bear an effective date of May 5, 2007.

5. Any responses to the Staff's recommendation shall be filed no later than April 30, 2007.
6. This order shall become effective on April 11, 2007.
