STAFF RECOMMENDATION

- 1. On July 7, 2008, Missouri Gas Utility, Inc. (MGU) filed tariff sheets with the Commission to comply with the Commission's *Order Granting Certificate of Public Convenience And Necessity* issued June 19, 2008. On July 11, 2008, MGU filed substitute tariff sheets that make modifications to MGU's tariff to the description of MGU's service area in the heading (the counties are listed instead of certain municipalities). Also, the map on Sheet No. 3 contains a change to better identify the location of Pattonsburg. The proposed tariff has the required 30 days notice by proposing an effective date of August 6, 2008.
- 2. On July 8, 2008, the Commission issued its *Order Directing Filing*, directing the Staff to file its recommendation on the tariff filing by July 28, 2008. The Staff has completed its review of MGU's tariff sheets and has determined the proposed tariff sheets comply with the Commission's Order. For the reasons stated in Staff's Memorandum, attached hereto as Appendix A and incorporated by reference, the Staff recommends MGU's tariff sheets filed on

July 8, 2008, and as substituted on July 11, 2008, be allowed to become effective on August 6, 2008.

WHEREFORE, for the above-stated reasons, Staff respectfully recommends the Commission allow MGU's tariff sheets become effective by operation of law on August 6, 2008.

On July 7, 2008, Missouri Gas Utility, Inc. (MGU or Company), filed tariff sheets with the Missouri Public Service Commission (Commission) to comply with the Commission's ORDER GRANTING CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY (Order), issued June 19, 2008, in this case. On July 11, 2008, MGU filed substitute tariff sheets The substitute sheets make modifications to MGU's tariff to the description of MGU's service area in the heading (the counties are listed instead of certain municipalities), and the map on Sheet No. 3 also contains a change to better identify the location of Pattonsburg. The proposed tariff has the required 30 days notice by proposing an effective date of August 6, 2008.

The three tariff sheets were also filed in Case Nos. GA-2008-0321 and GA-2008-0322 to comply with the Commission's ORDER DIRECTING FILING in those cases.

On April 22, 2008, Missouri Gas Utility, Inc. (MGU or Company) filed an APPLICATION (Application) with the Missouri Public Service Commission (Commission). The Application requests that the Commission grant MGU a certificate of convenience and necessity (CCN) authorizing it to construct, install, own, operate, control, manage and maintain a natural gas distribution system to provide gas service in Daviess County, Missouri, as a further expansion of its existing certified area.
