## ORDER APPROVING COMPLIANCE TARIFFS

Issue Date: January 14, 2010

Effective Date: January 14, 2010

The Missouri Public Service Commission is approving the tariff sheets ("tariffs") filed in compliance with the order that the Commission issued in this file on November 12, 2009, granting a certificate of convenience and necessity ("decision") to Missouri Gas Utility, Inc. ("MGU"). MGU filed the tariff sheets on December 18, 2009. On January 8, 2010, the Commission's staff filed its recommendation. The recommendation included an affidavit in support of a memorandum.

The Commission may decide the tariffs without hearing,<sup>1</sup> so the Commission bases its decision on the verified memorandum.<sup>2</sup> The memorandum states that the tariffs comply with the decision, conform to the Commission's regulations, and will simplify future filings through better organization and efficiency. Staff recommends approving the tariffs.

The Commission independently concludes that the tariffs set just and reasonable rates, and provide for safe and adequate service, and will therefore approve the tariffs.
