**ORDER SETTING DEADLINE FOR FILING RESPONSE TO  
MOTION TO DISMISS**

Effective Date: December 5, 2016

On November 30, 2016, Laclede Gas Company ("Laclede") filed a Response to Mr. Wehrle's October letter to the Commission. Laclede also filed a Motion to Dismiss with Prejudice. Laclede states that Mr. Wehrle's original complaint fails to identify what law or Commission order the company is alleged to have violated. Laclede also states that if the Commission grants the request to dismiss, it will honor a prior agreement to pay Mr. Wehrle \$100 for any past inconvenience he may have suffered.

The Commission will set a deadline for Mr. Wehrle to file a response to Laclede's Motion to Dismiss with Prejudice. Should Mr. Wehrle object to Laclede's request to dismiss the complaint, the Commission will direct him to state what statute, rule, tariff or order he alleges the company violated.

**THE COMMISSION ORDERS THAT:**

1. No later than December 12, 2016, Mr. Wehrle shall file a response indicating if he objects to Laclede Gas Company's Motion to Dismiss with Prejudice.

Should Mr. Wehrle object to the motion, the response shall specify what statute, rule, tariff, or Commission order he alleges the company violated.

2. The Commission's Data Center shall mail a copy of this order to Mr. Wehrle.

3. This order shall be effective when issued.
