Complainant then stated other grounds on which he believes the Commission should grant him relief. Both Staff and Spire state that the Commission should order Spire to treat Complainant's second claim as an amended complaint, and should further order Spire to answer the amended complaint. Spired filed an amended answer. Both Staff and Spire also further state that rather than litigating these disputes, the parties would be better served negotiating, and perhaps using a mediator, to resolve their disputes.

The Commission will order the parties to state how they wish to proceed.

1. The parties shall report to the Commission how they wish to proceed with this complaint no later than December 31, 2017.
2. This order shall be effective when issued.
