VERIFIED STATEMENT

COMES NOW, Union Electric Company d/b/a AmerenUE ("Company"), a Missouri corporation, in response to an Order Directing Filing dated October 6, 2005 of the Missouri Public Service Commission ("Commission"), states as follows:

1. Company is a corporation organized and existing under the laws of the State of Missouri, in good standing in all respects, with its principal office and place of business located at One Ameren Plaza, 1901 Chouteau Avenue, St. Louis, Missouri 63103. Company is an electrical corporation subject to the jurisdiction of the Commission and engaged in the sale and distribution of electricity in portions of Missouri, including the area in and around 107 Rushing Road, Scott City, Missouri 63780.

3. Case No. EO-2006-0145 involves an application by Girardeau Stevedores Contractors (“GSC”) for Commission approval of a change of its electric service provider from SEMO Electric Cooperative (“SEMO”) to Company. In support of its Application, GSC states that SEMO is unable to provide three phase electric service to their warehouse facilities, and as a result must use generators to power equipment in their warehouses and dock areas. Company has no knowledge regarding this assertion.

4. Company admits that it is prevented by RSMo § 394.315 2004 from providing three-phase electric service to GSC’s warehouses because SEMO is presently providing single phase service to the structures.

5. The Company takes no position whether this requested change in electric supplier is in the public interest for reasons other than rate differential. Notwithstanding the foregoing, Company is willing and able to provide three-phase electric service to GSC’s warehouses in the event the Commission finds GSC’s request in the public interest. In such an event, Company respectfully requests that the Commission’s order authorize Company to provide three-phase electric service to GSC’s warehouses and dock area.






