

Q. Please state your name and business address

A. My name is Carol Gay Fred, and my business address is 200 Madison Street, Suite 800, Jefferson City, MO 65101.

Background of Witness

Q. Are you the same Carol Gay Fred who filed comments in the Staff's Report on Cost of Service, filed on November 17, 2010?

A. Yes.

Purpose of Testimony

Q. What is the primary purpose of your testimony?

A. The purpose of my testimony is to address KCP&L Greater Missouri Operations (GMO or Company) Low Income Programs.

1 **Low Income Programs**

2 Q. In Staff's Report on Cost of Service filed on November 17, 2010, Staff
3 recommended that the company should be allowed to recover only fifty percent of the cost of
4 the Economic Relief Pilot Program (ERPP) at the time based on Jimmy Albert's testimony.
5 However, from discovery of information recently received from the Company, the Company
6 has acquired a sufficient number of participates in their ERPP. The number of participants in
7 the ERPP appears to be sufficient to request the cost recovery of deferred cost created because
8 the new customers enrolled. Therefore, I would like to withdraw my previous
9 recommendation on this matter, and now recommend, full recovery of the cost of the
10 Economic Relief Pilot Program as requested.
