I apologize for not being able to respond to your e-mail sooner. Bill Downey was out of town due to illness in his family. As Mr. Downey stated in our telephone conversation on Wednesday, February 20, a reforecast process of cost and schedule is underway foe both the latan 1 and 2 construction projects. latan 2 engineering and design is nearly 70% complete. Our expert consultants have indicated it is normal practice to conduct a reforecast once design reaches 70%, and again at 90% completion for this type of major project. In addition, latan 1 design is nearly complete and outage schedule and cut-over of the new equipment is currently under review along with cost for latan 1. Mr. Downey's offer to the Commission's Staff to observe the reforecast process was nothing more than our continued attempt to be as transparent as possible regarding the design, construction, cost and schedule of these projects. We have no preconceived notion of Staffs role other than observation and monitoring of the process.
