## ORDER APPROVING TARIFF IN COMPLIANCE WITH COMMISSION **REPORT AND ORDER**

In an Order Approving Stipulation and Agreement issued on February 23, 2006, the Commission rejected a tariff filed by Aquila, Inc. The Commission, however, authorized Aguila to file a revised tariff that was agreed to as part of the approved stipulation and agreement. Aguila filed a revised tariff on February 24.

The tariff sheets filed by Aquila on February 24 carry an effective date of March 26. However, Aquila filed a Motion along with its tariff, requesting that the Commission expedite its consideration of the tariff so that the tariff can go into effect on March 1, as provided in the approved stipulation and agreement.

Staff filed its recommendation regarding Aguila's tariff on February 28. Staff indicates that the tariff complies with the approved stipulation and agreement, and recommends that the Commission approve the tariff to become effective on March 1. No other party has filed a recommendation regarding the tariff.

Based on Staff's recommendation, the Commission determines that the tariff complies with the approved stipulation and agreement. The tariff will be approved

effective for service on and after March 1, for good cause shown, in compliance with

Section 392.140(11), RSMo 2000.
