### First Amendment to the Fourth Territorial Agreement

This First Amendment to the Fourth Territorial Agreement ("Amendment") between White River Valley Electric Cooperative ("White River") and The Empire District Electric Company d/b/a Liberty ("Liberty") is entered into this \_\_\_\_ day of \_\_\_\_\_\_, 2022. White River and Liberty are collectively referred to as the "Parties" herein.

**WHEREAS**, White River and Liberty filed a Joint Application with the Missouri Public Service Commission ("PSC") seeking approval of their Fourth Territorial Agreement on December 5, 2003; and

**WHEREAS**, the PSC approved the Fourth Territorial Agreement by Order issued in Case No: 2004-0246 dated March 16, 2004 and made effective March 26, 2004; and

**WHEREAS**, the Parties now seek to amend the Exclusive Service Area of Liberty as originally approved in the Fourth Territorial Agreement in exchange for certain territory that White River will be allowed to exclusively serve within the City of Branson, Missouri so existing facilities can be better utilized, avoiding duplication of service, all in the public interest; and

**WHEREAS,** the Parties are the only electric service suppliers in the contemplated territories, and the redefinition of Liberty's exclusive service area under the Fourth Territorial Agreement and the exchange of territory for White River's exclusive service are as contemplated herein will allow customers and members to know with certainty who their electric service provider will be and will allow the applicants to appropriately invest in and plan for serving the public within these territories; and

**WHEREAS**, this Amendment will also resolve the pending Change of Electric Supplier Case before the PCS in Case No.: EO-2022-0249, and the parties have negotiated, in good faith, to resolve differences related to that case, and have reached a compromise that is in their respective best interest as well as the public interest;

**Now Therefore**, the Parties hereto agree to amend the Fourth Territorial Agreement as set forth below:

#### **AGREEMENT**

Article 3 of the Fourth Territorial Agreement shall be amended and restated to read as follows:

- 3.A. White River, pursuant to this Fourth Territorial Agreement, shall be entitled to provide permanent service to all structures now located within the Canyon Springs of Branson development ("Canyon Springs") and all new structures within Canyon Springs and therefore it shall be considered the exclusive Service Area of White River, as between Empire (a/k/a "Liberty") and White River *EXCEPT THAT* Liberty shall be allowed to serve existing and new structures in Canyon Springs identified in **Exhibits Liberty-1** through **Liberty-3** attached hereto.
- 3.B. Liberty, pursuant to this Fourth Territorial Agreement, shall be entitled to provide permanent service to all structures it is now serving and all new structures within Canyon Springs and those lots and parcels within the area identified in Exhibits Liberty-1 through Liberty-3; therefore, these areas shall be considered the exclusive service area of Liberty, as between Liberty and White River. White River shall not be allowed to serve any existing or new structures within Canyon Springs in the area identified in Exhibits Liberty-1 through Liberty-3.

- 3.C. White River shall be allowed to serve the lots and parcels identified in **Exhibit White River-1** and **White River-2** attached hereto and incorporated herein by reference, said area comprising the development to be known as Elevate Branson located in Branson, Missouri.
- 3.D. This Agreement does not purport to affect the rights of any electric supplier not a party to it.

All other provisions of the Fourth Territorial Agreement shall remain in full force and effect as set forth in that Agreement on file with the PSC in Commission Case No. EO-2004-0246.










