

INITIAL CUSTOMER NOTICE

August 20, 2014

Dear Customer:

On July 18, 2014, Gascony Water Company (Company) submitted a request for an increase in its annual water operating revenues to the Missouri Public Service Commission (Commission). The reason for the increase is to cover recent replacement of the pump, motor and controls for the Company's well; increases in the Company's operation and maintenance expenses; and proposed rent and salary increase.

By its request, the Company is seeking changes to its customer rates intended to generate an increase in its annual water operating revenues of \$12,353 (approximately 33.5%). At the end of this notice is a table that compares the Company's current quarterly residential customer rates and the proposed quarterly residential rates.

To provide comments regarding the Company's revenue increase request, or comments regarding service-related problems, please contact the Commission Staff and/or the Office of the Public Counsel (Public Counsel) ***within 30 days of the date of this notice***. Your comments should include a reference to case number WR-2015-0020. The Commission Staff and the Public Counsel will review all customer comments submitted in response to this notice. All comments will be filed in the official case file for review by the Commissioners.

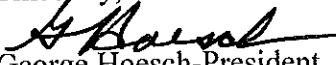
