ORDER APPROVING TARIFF AND GRANTING VARIANCE

Issue Date: February 28, 2008

Effective Date: March 3, 2008

On January 31, 2008, Aquila Networks, a division of Aquila, Inc., filed a revised tariff that implements a new Missouri statute, the "Net Metering and Easy Connection Act",¹ which took effect on January 1, 2008. Aquila's tariff carries an effective date of March 3.

The Commission's Staff filed a recommendation regarding the proposed tariff on February 25. Staff recommends the Commission approve Aquila's tariff to take effect on the proposed effective date. Staff also recommends the Commission grant Aquila a variance from the Commission's current net metering rule, 4 CSR 240-20.065, until the Commission rescinds that rule and replaces it with a new rule consistent with the revised statute.²

Based on the recommendation of its Staff, the Commission will approve the submitted tariff. In addition, the Commission will waive application of the current net metering rule.

IT IS ORDERED THAT:

1. The tariff issued by Aquila, Inc., d/b/a Aquila Networks for territory served by Aquila Networks – L&P and Aquila Networks - MPS, on January 31, 2008, and assigned Tariff No. JE-2008-0458, is approved to become effective on March 3, 2008. The tariff sheets approved are:



2. Aquila, Inc., d/b/a Aquila Networks, is granted a waiver from compliance with Commission Rule 4 CSR 240-20.065 until the Commission rescinds that rule and adopts a new rule consistent with the Net Metering and Easy Connection Act.

4. This case shall be closed on March 4, 2008.
