ORDER SHORTENING TIME FOR RESONSES TO CORRECTED STAFF MEMORANDUM

On June 1, 2022, Evergy Metro, Inc. d/b/a Evergy Missouri Metro filed a tariff, with supporting testimony, to adjust charges related to its approved Demand Side Investment Mechanism (DSIM) Rider. On June 30, 2022, the Staff of the Commission (Staff) filed a recommendation and memorandum. On July 7, 2022, Staff filed its Corrected Staff Recommendation to Approve Tariff Sheet (Corrected Recommendation). The Commission will be basing its decision on the Corrected Recommendation.

The Commission has sixty days to act on Evergy Missouri Metro's filing, which is Sunday, July 31, 2022. The normal 10-day response period under 20 CSR 4240-2.080(13) to Staff's Corrected Recommendation would expire July 17, 2022. The Commission will shorten the time for responses to allow sufficient time for consideration by the Commission.

1. No party is required to respond, but any party that wishes to respond to Staff's Corrected Recommendation shall do so on or before July 14, 2022.

2. This order shall be effective when issued.
