# ORDER DIRECTING AN EXPEDITED STAFF TIME-OF-USE TARIFF RECOMMENDATION AND SETTING TIME FOR TIME-OF-USE TARIFF RESPONSES AND OBJECTIONS TO TIME-OF-USE TARIFF SHEETS BECOMING EFFECTIVE ON JULY 1, 2023

On June 22, 2023, Union Electric Company d/b/a Ameren Missouri filed time-ofuse tariff sheets to comply with the Commission's June 14, 2023 Report and Order along with a request for expedited treatment. Those time-of-use tariff sheets bear an effective date of July 22, 2023, but Ameren Missouri has requested those tariff sheets take effect on July 1, 2023.

The Commission will direct its Staff (Staff) to file an expedited recommendation about whether those time-of-use tariff sheets comply with the Commission's Report and Order and whether Staff objects to Ameren Missouri's compliance tariff sheets taking effect on July 1, 2023. The Commission will also give parties until June 23, 2023, to file comments or objections about Ameren Missouri's time-of-use compliance tariff sheets, to object to those tariff sheets becoming effective on July 1, 2023, or to indicate that they need additional time to examine the time-of-use tariff sheets.

# THE COMMISSION ORDERS THAT:

1. Staff must file a recommendation about the time-of-use tariff sheets filed by Ameren Missouri no later than June 23, 2023, at 3:00 p.m. Staff's recommendation must also state whether Staff objects to the time-of-use tariff sheets taking effect on July 1, 2023. If Staff needs additional time to examine the time-of-use tariff sheets it shall inform the Commission no later than June 23, 2023, at 3:00 p.m.

2. Any other responses to the time-of-use tariff sheets or any requests for additional time to examine the time-of-use tariff sheets must be filed no later than June 23, 2023, at 3:00 p.m.

3. Any objections to Ameren Missouri's time-of-use tariff sheets taking effect on July 1, 2023, or requests for additional time to object must be filed no later than June 23, 2023, at 3:00 p.m.

4. This order is effective when issued.
