### STAFF RESPONSE TO COMMISSION ORDER

**COMES NOW** Staff of the Missouri Public Service Commission and for this Staff Response to Commission Order respectfully states as follows:

- 1. On June 27, 2023 at approximately 2:59 pm the Commission stated in its *Order Directing Response*, that "Staff asked that it be granted additional time to complete any further review of Union Electric Company d/b/a Ameren Missouri's exemplar tariff sheets." In its first ordered paragraph the Commission directed that "Staff shall respond today, June 27, 2023, indicating how long it needs to complete review of Ameren Missouri's exemplar tariff sheets." In its second ordered paragraph the Commission further directed that Staff "Staff shall respond today, June 27, 2023, as to how long it would need to review substitute tariff recalculated for an effective date beyond July 9, 2023."
- 2. Regarding the directive of the first ordered paragraph, Staff apologizes for any lack of clarity in its *Recommendation and Response to Commission Orders* filed at 1:22 pm on June 27, 2023. To clarify, no further review of the Exemplar tariffs filed by Ameren Missouri on June 26, 2023 is necessary because these tariffs have not been submitted as a compliance tariff submission. In its 1:22 pm filing Staff simply sought to clarify that Ameren Missouri's June 26, 2023 Exemplar tariff submission included 108 tariff sheets that would not change contents with a change in tariff rate effective date.
- 3. Regarding the directive of the second ordered paragraph, Staff estimates that review of the 18 tariff sheets that bear rate values that are subject to adjustment with a change in tariff sheet effective date to July 9, 2023 and preparation of a Recommendation and

affidavits requires approximately 4 - 8 hours. This comparison will be fairly straightforward to conduct as the relevant rate values are already reflected in Staff's working copy of the compliance tariff sheet review packet, and may be concluded in less than the stated time frame.

- 4. If the tariff effective date is extended to a date "beyond July 9, 2023," then the LPS cap will require recalculation, and further collaboration with Ameren Missouri to develop the compliance rate values reflecting a reasonable proof of revenue based on the stipulated billing determinants, ordered language, and the statutory LPS cap calculated as of a different date. Such a comparison may require a complete business day, and may involve review of 20 tariff sheets and require cross-reference review to the proof of revenue rate values.
- 5. If Ameren Missouri submits compliance tariff submissions including all 128 sheets, regardless of effective date, more than one business day will be required for Staff's review.
- 6. Staff recommends that if the Commission is to effectuate a July 9, 2023 rate increase effective date for Ameren Missouri, it enter an order directing Ameren Missouri to substitute the relevant tariff sheets in its tariff submissions Tracking No. YE-2023-0222 as reflected in the exemplar tariff sheets filed on June 26, 2023 for the following 18 tariff sheets:
