During the evidentiary hearing held on September 30, 2022, counsel for the Staff of the Commission (Staff) stated that Staff would file its Exhibit No. 101 – the Staff Recommendation in Commission File No. ER-2022-0005 – following the hearing. The presiding judge gave the parties 24 hours after the filing in which to file any objections to the admission of the exhibit into evidence.
