1 P R O C E E D I N G S

2 JUDGE BUSHMANN: Let's go on the record.  
3 Today is November 24th, 2014, at 10:00 a.m. The  
4 Commission has set this time for a pre-hearing  
5 conference in the case captioned as In the Matter  
6 of Kansas City Power & Light Company's Request for  
7 Authority to Implement a General Rate Increase for  
8 Electric Service, File No. ER-2014-0370.

9 My name is Michael Bushmann. I'm the  
10 Regulatory Law Judge that's been assigned to this  
11 matter. Let's start with having Counsel make their  
12 entries of appearance. For Kansas City Power &  
13 Light Company?

14 MR. FISCHER: Yes, Judge. Let the record  
15 reflect the appearance of Roger W. Steiner and  
16 James Fischer for the company. Our contact  
17 information is on the written form that I have  
18 given to the court reporter.

19 JUDGE BUSHMANN: Thank you. Commission  
20 Staff?

21 MR. WILLIAMS: Nathan Williams, Deputy  
22 Staff Counsel, P.O. Box 360, Jefferson City,  
23 Missouri, 65102.

24 JUDGE BUSHMANN: Office of Public Counsel?

25 MR. OPITZ: For the Office of Public

1 Counsel, Tim Opitz, P.O. Box 2230, Jefferson City,  
2 Missouri, 65102.

3 JUDGE BUSHMANN: We have a number of  
4 parties -- or entities that have applied for  
5 intervention, so I suspect we have Counsel from  
6 those parties. Brightergy, LLC?

7 MR. ZELLERS: Yes, your Honor, Andy  
8 Zellers, General Counsel of Brightergy, 1617 Main  
9 Street, Third Floor, Kansas City, Missouri, 64108.

10 JUDGE BUSHMANN: Missouri Industrial  
11 Energy Consumers?

12 MR. WOODSMALL: Thank you, your Honor.  
13 David Woodsmall appearing on behalf of MECG. Oh,  
14 did you say MECG or Missouri Industrial Energy  
15 Consumers?

16 JUDGE BUSHMANN: Missouri Industrial  
17 Energy Consumers.

18 MR. WOODSMALL: I'm sorry, your Honor. I  
19 was a little premature there.

20 JUDGE BUSHMANN: I'll consider you for the  
21 other one. And that's --

22 MR. WOODSMALL: MECG.

23 JUDGE BUSHMANN: Okay. Any other for  
24 Missouri Industrial Energy Consumers? Is there an  
25 appearance here for that? City of Kansas City?

1 Missouri Division of Energy?

2 MR. KNEE: Yes, your Honor. On behalf of  
3 the Department of Economic Development, Division of  
4 Energy, Jeremy Knee. And the court reporter has my  
5 address.

6 JUDGE BUSHMANN: Consumer Council of  
7 Missouri?

8 MR. COFFMAN: Appearing on behalf of the  
9 Consumers Council of Missouri, John B. Coffman.  
10 I've submitted my address on the form.

11 JUDGE BUSHMANN: Ameren Missouri? IBEW  
12 Unions? Sierra Club? Missouri Gas Energy?

13 MR. BOUDREAU: Yes, Judge. Appearing on  
14 behalf of the Laclede Gas Company doing business as  
15 Missouri Gas Energy, Paul A. Boudreau. I've given  
16 my contact information to the court reporter.

17 JUDGE BUSHMANN: Thank you. U.S.  
18 Department of Energy and Federal Executive  
19 Agencies?

20 MR. PORTER: Yes. Thank you, your Honor.  
21 Steve Porter, Assistant General Counsel for  
22 Electricity and Fossil Energy.

23 JUDGE BUSHMANN: Have I missed anyone?  
24 Good. Apparently not. So on the intervention  
25 requests, the Commission will be taking up the

1 applications of Brightergy, LLC, and Consumers  
2 Council of Missouri at agenda today since there was  
3 a dispute about those requests.

4 There wasn't time to get the Ameren  
5 Missouri intervention dispute before the Commission  
6 today for resolution, so that will have to be  
7 decided probably at agenda next week. Are there  
8 any objections to granting intervention to the  
9 other applicants?

10 MR. WOODSMALL: Your Honor, if I could  
11 just state a preliminary matter, MECG has asked to  
12 intervene and listed a number of its participants.  
13 That was done Thursday afternoon.

14 Early on Friday, two new participants, two  
15 new companies have asked to participate. They are  
16 similarly situated to the others. Those are  
17 Harrah's casino and Isle of Capri casino.

18 I don't believe that their -- or their  
19 addition one day late will prejudice any of the  
20 parties. So I'd like to add them to my list. And  
21 I could do that with a written pleading if you  
22 prefer or however you want that done.

23 JUDGE BUSHMANN: You probably ought to go  
24 ahead and make that just so it's on the record in  
25 EFIS.

1 MR. WOODSMALL: Okay.

2 JUDGE BUSHMANN: But about that addition,  
3 is there any objection to MECG's application or any  
4 of the other intervenors other than the ones that  
5 have already been in dispute, Brightergy, Ameren  
6 and Consumers Council?

7 MR. FISCHER: No objection from the  
8 company, Judge.

9 JUDGE BUSHMANN: All right. Hearing none,  
10 then, then intervention requests are granted for  
11 Missouri Industrial Energy Consumers, City of  
12 Kansas City, Missouri Division of Energy, IBEW  
13 Unions, Sierra Club, Missouri Gas Energy, U.S.  
14 Department of Energy and Federal Executive Agencies  
15 and Midwest Energy Consumers Group as amended,  
16 which will be following to be filed. So I will  
17 issue a notice in EFIS today documenting that  
18 order.

19 The next thing we need to worry about is a  
20 joint procedural schedule. I would like to have  
21 the parties file a joint proposed procedural  
22 schedule by December 2nd.

23 You should include substantially the same  
24 items that were in the procedural schedule in the  
25 previous rate case, EC-2012-0174.



1 I'd also like you to include a test year  
2 with update period, true-up recommendations,  
3 suggested dates and locations for local public  
4 hearings, dates for mail and customer notices, and  
5 a Joint Stipulation of Non-Disputed Material Facts.

6 MR. STEINER: A date for that, Judge?

7 JUDGE BUSHMANN: Have that included in  
8 your schedule of events when that would be filed.

9 MR. STEINER: Right. But the date for  
10 that Joint Stipulation, not an actual Stipulation,  
11 but joint material facts, right?

12 JUDGE BUSHMANN: Right. Just a date for  
13 when that would be filed close to the hearing.

14 MR. STEINER: Got you.

15 JUDGE BUSHMANN: Recently, there has been  
16 disagreements in other cases about parties having  
17 sufficient time to review compliance tariffs.

18 So since the operation of law a date in  
19 this case is September 29th, 2015, by my  
20 calculations, the Commission will need to vote out  
21 an order no later than September 2nd.

22 And for that to happen, that means final  
23 briefs will need to be in by July 27th. So I'd  
24 like you to take those dates into consideration  
25 when you're coming up with your procedural
