6	Q. Please state your name and business address.							
7	A. My name is Amanda Coffer, and my business address is Missouri Public Service							
8	Commission, P.O. Box 360, Jefferson City, Missouri, 65102.							
9	Q. Are you the same Amanda Coffer who previously filed testimony in this case?							
10	A. Yes I am.							
11	SOLAR REBATE TARIFF							
12	Q. What is Ameren proposing in regards to its solar rebate tariff?							
13	A. In his testimony, Ameren witness Michael Harding mentions the plan to							
14	eliminate the outdated solar rebate language in Sheet Nos. 88.9 -88.13.1							
15	Q. Does Ameren currently have two solar rebate riders in its tariff?							
16	A. Yes. Rider SR found in Sheet Nos. 88.9-88.13 and 88-88.8.							
17	Q. What is the difference in these two riders?							
18	A. Sheet Nos. 88.9-88.13 implemented the requirements in 393.1030.3. RSMo,							
19	which outlined solar rebate requirements from June 30, 2014 through June 30, 2020; and							
20	Sheet Nos. 88-88.8 implemented the requirements in 393.1670 RSMo, which outlines solar							
21	rebate requirements from January 1, 2019 through December 31, 2023.							
22	Q. You previously mentioned the language in Sheet Nos. 88.9-88.13 is outdated.							
23	How is it outdated?

1	A. The purpose of the Rider SR found in Sheet Nos. 88.9-88.13 was to implement							
2	the solar rebate established through 393.1030 RSMo. Section 393.1030.3 outlined							
3	requirements for solar rebates for systems that became operational prior to June 30, 2020							
4	After June 30, 2020 there is no requirement. The requirement states in part,							
5	"The solar rebates shall be two dollars per watt for systems becoming operational on or							
6	before June 30, 2014; one dollar and fifty cents per watt for systems becoming operational							
7	between July 1, 2014, and June 30, 2015; one dollar per watt for systems becoming operational							
8	between July 1, 2015, and June 30, 2016; fifty cents per watt for systems becoming operational							
9	between July 1, 2016, and June 30, 2017; fifty cents per watt for systems becoming operational							
10	between July 1, 2017, and June 30, 2019; twenty-five cents per watt for systems becoming							
11	operational between July 1, 2019, and June 30, 2020; and zero cents per watt for systems							
12	becoming operational after June 30, 2020."							
13	Q. With this change will Ameren still be offering solar rebates to customers?							
14	A. Yes. Ameren will still be offering solar rebates through Rider SR on tariff Sheet							
15	Nos 88-88.8 which is in effect through 2023.							
16	Q. What is your recommendation regarding this change?							
17	A. I recommend the Commission approve the elimination of the outdated solar							
18	rebate language in Sheet Nos. 88.9 -88.13.							
19	Q. Does this conclude your direct testimony?							
20	A. Yes it does.
