**NOTIFICATION**

COMES NOW Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri" or "Company") and, pursuant to the terms of its tariffs approved to implement the energy efficiency portfolio approved in this case, submits the following:

1. Ameren Missouri's Change Process tariff, found at Sheet No. 221.4 of its Energy Efficiency MEEIA 2019-21 tariffs, states that the Company will file a notice in this case prior to making a change in its measure and/or incentive amount offering.

2. Ameren Missouri is modifying several of its programs in light of the COVID-19 pandemic. Ameren Missouri is modifying its commercial lighting incentives to re-energize the market and increase customer participation by creating a bundled package of interior and exterior lighting. The bundled package will require that exterior lighting measures be submitted with new interior lighting measures to be eligible for an incentive. The bundled package will cap the exterior lighting incentive at 30% of the final interior lighting incentive.

3. Attachment A to this *Notification* contains the program guidelines. This bundled package will be implemented by October 2, 2020, and will conclude December 31, 2020.

**WHEREFORE**, Ameren Missouri respectfully files this *Notification* in compliance with the terms of its tariff.

## **2020 BUNDLED EXTERIOR LIGHTING GUIDELINES**

### **1.1 DESCRIPTION**

The Ameren Missouri BizSavers Program has incentives available on exterior lighting improvements for eligible Commercial and Industrial customers. The exterior lighting project must be coupled with a new interior lighting project at that site.

### **1.2 OBJECTIVE**

The objective of the 2020 Bundled Exterior Lighting program is to increase participation by incenting Ameren Missouri customers to use energy efficient equipment through the BizSavers Program to invest back into their business while saving on both upfront cost and ongoing operational costs.

### **1.3 DATES AND TIMELINES**

- 2020 Packaged Exterior Lighting program "**Start Date**": October 2<sup>nd</sup>, 2020
- 2020 Packaged Exterior Lighting program "**End Date**": December 31<sup>st</sup>, 2020

### **1.4 ELIGIBILITY**

- Eligible Efficient Technologies: Any exterior LED lighting
  - Exterior lighting specification life must be  $\geq 50,000$  hours
- Exterior lighting must be bundled with programs that include interior lighting
- Each exterior lighting measure must pass the Total Resource Cost test to qualify, which is validated within the application.
- Project Eligibility
  - Bundled Program Fast Track Projects ( $< \$15,000$  incentive)
    - New lighting projects received within the timeframe established by the Start and End Dates listed above are eligible
  - Bundled Program Pre-Approval Projects ( $\geq \$15,000$  incentive)
    - Projects without a BizSavers incentive offer within the timeframe established by the Start and End Dates listed above are eligible

### **1.5 DETAILS**

- A previously non-submitted interior lighting project must accompany the exterior scope on the application.
- The incentive rate for exterior lighting measures is \$0.10 per kWh saved.
- The total exterior lighting incentive will be capped at 30% of the final interior lighting incentive.
- Any active bonus will not apply to the kWh or incentive associated with exterior lighting
- Projects must be installed and all completion paperwork submitted by December 31<sup>st</sup>, 2020.
- Exterior incentive cannot exceed 50% of total cost (material, labor, disposal, etc.) of exterior lighting project.
- The interior lighting measures that are part of the Bundled Exterior lighting project must adhere to the Standard Program guidelines.
