NOTICE OF CLARIFICATION

Issue Date: January 16, 2007

On January 11, 2007, the Commission issued a notice that indicated as follows:

The parties are notified that representatives of AmerenUE will appear at the Commission's January 18, 2007 agenda meeting, at 11:00 a.m., to discuss AmerenUE's response to the Commission's concerns about the reliability of electric service following severe weather events.

On the same date, the Commission issued an order in Case No. EO-2007-0037 that scheduled an on-the-record presentation in that case for January 18 at 11:00 a.m., to allow AmerenUE to "respond formally to the recommendations in Staff's Report, to provide the parties an opportunity to provide the Commission with any additional information, and to allow the Commissioners the opportunity to ask questions about the response." EO-2007-0037 is the case established to investigate AmerenUE's storm preparation and restoration efforts.

On January 16, the Office of the Public Counsel filed a motion for clarification or reconsideration expressing confusion about the Commission's intentions. Public Counsel

asks whether the notice in this case and the order in EO-2007-0037 refer to the same event, and whether the on-the-record presentation is being held in both cases.

The Commission will clarify that there is only one event planned for January 18. That is an on-the-record presentation in Case No. EO-2007-0037. The notice that was issued in ER-2007-0002 and GR-2007-0003 was intended merely to notify the parties to the rate cases that the on-the-record presentation would be held in Case No. EO-2007-0037. The on-the-record presentation will occur only in that case, and not in ER-2007-0002 and GR-2007-0003.

The Commission apologizes for any confusion that resulted from its January 11 notice.
